Report on Child Care in Cook County, 2022

This fact sheet is a bridge between our extensive 2021 Child Care in Cook County report, which examines the impact of COVID-19 on child care in the first year of the pandemic, and our forthcoming 2023 report which will revisit in detail the impact of the pandemic on the supply of and demand for care.¹

Types of Child Care Available in Cook County

Licensed Home Care

This is care offered in a person's home and regulated by the Illinois Department of Children and Family Services (DCFS). Licensed home providers may care for eight to twelve children. Providers with full-time adult assistants licensed as group homes can care for as many as 16 children. In June 2021 there were 2,606 licensed home providers in Cook County.

Center Care

Most child care centers are licensed through DCFS, though a number connected to schools or religious institutions are exempt from licensing. Centers provide care for dozens or even hundreds of children and must employ a staff and establish formal operating rules. In June 2021, 1,283 full-time centers operated in Cook County.

School-Age Care

In addition to school-age care offered through child care centers, before- and/or after-school care is offered by some schools, park districts, and programs such as the Boys and Girls Clubs. Most of these programs are exempt from licensing, making it difficult to get a complete count of them. In June 2021, 148 programs in Cook County listed with Illinois Action for Children.

Family, Friend, and Neighbor (FFN) Care

This is care provided by friends, neighbors and relatives in either the home of the child or the caregiver. FFN providers are permitted to care for up to three unrelated children at a time without a license. There is no registry of informal care providers and therefore the total number in Cook County is unknown.

Child Care Slots in Cook County Regions²

The formal child care sector comprised of full-day child care centers, school-age programs and licensed child care homes has the capacity to care for approximately 140,600 Cook County children. Not all programs operate at capacity, however, for various reasons including staff shortages. As there are about 581,000 children birth-through-12 in Cook County with all parents working, we estimate that 24 percent of children potentially in need of child care can be served in formal settings.

The remaining 76 percent of children in this category may be cared for by family, friend or neighbor providers, older siblings, license-exempt programs not listed with Illinois Action for Children, babysitters or nannies, public or private preschool programs, parents or guardians who work part-time or stagger their work schedules, or even self-care.

While not all child care centers report their slots by age to Illinois Action for Children, the data below reflect the capacity of the 71 percent that do. Comparable data for licensed homes are not reported because home providers have more flexibility in the ages of children they can enroll and the ages they serve change frequently.

Price of Care in Cook County Regions

Each year, Illinois Action for Children's Child Care Resource and Referral (CCR&R) program surveys providers on the rates they charge parents. The tables below present the rates for both licensed centers and licensed homes for the regions of Cook County based on child age as of June 2021.⁵ The final row of each table shows the maximum weekly reimbursement rate the State will pay on behalf of families eligible to receive assistance through the Illinois Child Care Assistance Program (CCAP).⁶
