## A Snapshot of Children in Congressional District 3

**24,720** children 0 to 2

## What child care options are available to families?

-  **188** Child care centers can serve up to **15,591** children
-  **279** Licensed child care homes can serve up to **3,124** children
-  **396** License-exempt home caregivers can serve around **846** children

## How much are families paying for child care?



MEDIAN FAMILY INCOME: **\$88,565**

**INFANT:** Average annual price of licensed care

-  Home-based: **\$12,626**
-  Center-based: **\$18,590**

This is **14%-21%** of a family's income.

**PRESCHOOLER:** Average annual price of licensed care

-  Home-based: **\$10,985**
-  Center-based: **\$12,989**

This is **12%-15%** of a family's income.

The cost of center care rivals college tuition: **\$15,348**

### CHILD CARE ASSISTANCE PROGRAM

The Child Care Assistance Program (CCAP), funded through IDHS, helps families pay for child care while they work or go to school.

### EARLY CHILDHOOD BLOCK GRANT

ILLINOIS STATE BOARD OF EDUCATION (ISBE)

**27** Prevention Initiative programs  
**1,519** children age 0-2  
**92** Preschool for All programs  
**6,281** children age 3-5

**7,800** children served

The Early Childhood Block Grant is funded by ISBE to help programs provide high-quality early education opportunities through Preschool for All (PFA) and Prevention Initiative (PI) services for infants, toddlers, and expectant families.

### HEAD START & EARLY HEAD START

US DEPARTMENT OF HEALTH & HUMAN SERVICES

**28** Early Head Start sites  
**1,146** children age 0-2  
**23** Head Start sites  
**930** children age 3-5

**2,076** children served

Head Start programs for 3- and 4-year-olds, along with Early Head Start for infants and toddlers, are federally-funded early education programs for families living below the poverty line and designed to meet the comprehensive needs of families.
