Advocacy Day Recap

Early Learning Advocacy Day: Building Tomorrow, Together was a success! On April 18, more than 300 supporters of early childhood care and education (ECEC) boarded buses from their respective neighborhoods from across the state. We, the Village coalition joined forces with Raising Illinois and Child Care for All and issued our loudest rallying cry yet to urge legislators to prioritize our state's youngest residents.

The day's highlight was a rally in the Capitol where Illinois Action for Children CEO April Janney had the privilege of introducing Governor JB Pritzker and Lieutenant Governor Stratton who joined us to promote the Smart Start plan and other ECEC initiatives to rousing cheers from the crowd of advocates. Senator Christina Pacione-Zayas and Representatives Katie Stuart, Joyce Mason, and Mike Porfirio were present to voice their strong support for early learning. It was exciting to join with legislators, providers, teachers, advocates, and many more to say YES to early childhood investments and a better future for our families.

Springfield Updates

Yesterday, Illinois Action for Children Senior Vice President of Programs Shauna Ejeh testified at the last Joint Early Childhood Education Committee hearing, which focused on workforce compensation, benefits, pipeline, and retention. She discussed the need for prioritizing the early childhood worker pipeline, better access to professional development opportunities, and increased compensation and benefits for early care staff. To meet the urgent needs of our workforce, we must make the critical investments outlined in Smart Start IL, including workforce compensation contracts.

Thank you to all those who testified for Smart Start IL and uplifted our early childhood workforce.

- \$75 million to fund thousands of new preschool seats
- \$130 million to raise child care worker wages
- \$70 million to deliver more direct payments to parents & child care providers
- \$5 million to support 1,500 more families through home visiting
- \$40 million for early intervention programs
- \$100 million to improve and expand child care facilities

Federal Policy Updates

On April 18, President Biden announced the most comprehensive set of executive actions any president has ever taken to improve care for hard-working families and workers. He signed an executive order that includes more than 50 directives to nearly every cabinet-level agency to expand access to affordable, highquality care and provide support for care workers and family caregivers.
