#### CCAP Billing Update from March to June 2021

For March through June, normal payment entry for the child care assistance program (CCAP) has been reinstated; there is now the 50 percent attendance rule, rather than the 80 percent attendance rule.

The COVID-19 exemption applies through care provided in February, in March providers will need to apply for a traditional attendance exemption through the Illinois Department of Human Services (IDHS).

#### American Rescue Plan and Child Care

We are thrilled to see support for the early childhood field in the president's American Rescue Plan. The plan, which has been passed by both houses of Congress and signed by President Biden this Thursday, includes \$39 billion in new funds for child care, this includes \$23 billion for the Child Care Stabilization Fund which provides direct support to providers to cover the cost of staying open. Illinois would receive \$800 million. The Rescue Plan also includes nearly \$15 billion for the Child Care and Development Block Grant, and Illinois would receive \$500 million of those funds. We will keep you updated on further federal support updates!
