State Senators Highlight Child Care Accessibility & Affordability in Recent Press Conference



"We had a family who paid a \$1 copayment, but now their copayment is \$216... It's time to fix a system that will better assist our youngest and most vulnerable children. We need policymakers to realize how important it is to make sure that every child has access to high-quality child care," said Penny Driver, the director of the Teddy Bear Christian Development Center.

This statement was made at a press conference held by State Senator Cristina H Pacione–Zayas, State Senator Ram Villivalam, Senate Leader Kimberly Lightford and State Senator Omar Aquino. They joined parents and child care providers from central Illinois to highlight the importance of increasing income eligibility for the Child Care Assistance Program and expanding the \$1 copayment for more families.

Let's continue to push for more accessible and affordable child care to ensure stability for our families and improve outcomes for our youngest children!

State Legislative Update

March was a busy month in Springfield. The Joint Early Childhood Education Committee led by State Senator Cristina Pacione–Zayas and Representative Joyce Mason is holding five subject matter hearings on the state of early childhood investments and the importance of a robust, overarching system that ensures quality care for all children. In other news, several bills impacting early childhood and education services made significant progress. This includes bills to establish full-day kindergarten (HB2396) and expand group day care home capacity (HB2474). Both passed the House and now moves to the Senate. In addition, a bill that extends the application for the 5-year Short-Term Substitute Teaching License (SB2390) passed the Senate and is now in the House. We'll keep you updated on their progress.

Federal Policy Updates

It's that time of year again when Congress is working hard to pass a budget for Fiscal Year 2024. And it's important to remind legislators that making significant and sustained investments for our children and families matters. Urge your members of Congress to build on the bipartisan progress made in the Fiscal Year 2023 omnibus by investing in programs families need to thrive.
