IAFC's Response to Governor Pritzker's 2024 Budget Address

On Wednesday, February 21, 2024, Governor Pritzker unveiled his proposed Fiscal Year 2025 (FY25) budget for Illinois, highlighting significant investments for children and families. IAFC is excited to see proposed investments to create the new Department of Early Childhood, continue the Smart Start Initiative to year two, and prioritize other child care needs in his FY25 budget proposal.

These are big wins for early childhood in the proposed FY25 budget. However, we need Illinois to fund the entire early childhood education and care system and ensure our incumbent workforce and early intervention programs are not left behind.

The Department of Early Childhood Act is a monumental step towards ensuring that Illinois' parents and providers experience an ECEC system that is simple, coordinated, and equipped to support them and the children they care for. Round 4 opens on April 1, 2024. INCCRRA administers these grants in order to provide stable and predictable funding to support workforce development. This will be the last round of transition grants before the transition to Smart Start Child Care, a new workforce grant program that will have different eligibility from Strengthen and Grow and Smart Start Transition Grants. Federal Update

Tell Congress to Stabilize Childcare Now!

On February 28, Congressional leaders passed a partial budget deal that would continue level funding for programs set to expire and extended the deadline to pass a full budget for the next year to March 22. The Departments of Interior, and Justice, as well as the Environmental Protection Agency and a few other agencies, would keep their current March 8 deadlines.

We need to remind our members to protect and expand funding for child care and early learning programs. Without immediate action from Congress, states will lose critical funding to continue efforts to uplift the workforce, lower costs for families, and increase access to childcare. Act now!

<u>Send a message</u> to your elected officials to prioritize and invest in childcare, as they debate emergency funding and annual spending bills!

Expand the Federal Child Tax Credit

On January 31, the House passed a bipartisan tax credit bill, Tax Relief for American Families and Act of 2024, that will expand the valuable child tax credit for parents. This expansion will provide women, LGBTQIA+ people, and families with the support they need and deserve. The bill will head to the Senate for a vote, and we need you to make your voice heard and urge Illinois Senators to support the expansion of Child Tax Credit.
